- PRISM MPI2-10 Media Analysis Platform
- PRISM MPX2-10 Media Analysis Platform

Supported upgrades

These hardware upgrades are supported by this document:

• MPI2-10-UP PHY. Add SDI Physical Layer Measurement Package to the MPI2-10 product; includes automated measurement of 12G/3G/HD/SD-SDI Eye pattern parameters, jitter parameters and jitter waveform display.

(Option MP2-FMT-4K required for 12G support)

• MPX2-10-UP PHY. Add SDI Physical Layer Measurement Package to the MPX2-10 product; includes automated measurement of 12G/3G/HD/SD-SDI Eye pattern parameters and jitter parameters and jitter waveform display.

(Option MP2-FMT-4K required for 12G support)

Upgrade the PRISM MPI2-10 Eye mezzanine board

Complete the following steps to remove the currently installed mezzanine board from the instrument and install the Eye mezzanine board:

- 1. Set the instrument so the bottom is down on a static-free work surface.
- 2. Remove the top cover as follows:
 - **a.** Use a TORX-driver with a T-10 TORX tip to remove the thirteen screws securing the cover to the instrument.
 - **b.** Slide the cover back and then lift it from the back to remove it from the instrument; set the cover aside.

3. Use the 9/16 inch socket nut driver to remove the two BNC nuts and lock washers (SDI IN 1 and 2).

4. Using a TORX-driver with a T-10 TORX tip to remove the screw securing the BNC mezzanine board.

5. Gently lift the back of the BNC mezzanine board from its connector and remove it from the Mixed Media board.

6. Locate the new Eye mezzanine board from the kit (part number 878-1285-XX).

7. Guide the BNC connectors through the bracket and line up the two board connectors with the connectors on the Mixed Media board.



CAUTION. Bending the Eye mezzanine board can damage the board or instrument. Avoid fully inserting the back connector until the front connector is properly aligned; this prevents the bending of the board.

- 8. Begin by engaging the connector near the BNCs. Do not fully insert.
- **9.** Line up the connectors furthest away from the BNCs. Finish inserting the first connector.
- **10.** Gently press the last connector into the Mixed Media board.

NOTE. The MPI2-10 Mixed Media board comes with a second spacer post installed. The spacer post in the kit will not be needed during the upgrade process.

11. Use a TORX-driver with a T-10 TORX tip to install the two screws in the Eye mezzanine board. Tighten these screws to $0.6 \text{ N} \cdot \text{m} (5.31 \text{ in-lb})$.

- **12.** Replace the two BNC nuts and lock washers. Tighten the BNC nuts to 1.0 N·m (8.85 in-lb).
- 13. Place the top cover over the instrument and use the TORX-driver with a T-10 TORX tip to reinstall the screws. Tighten these screws to $0.9 \text{ N} \cdot \text{m}$ (7.97 in-lb).

14. Apply the MPI2-10-UP serial number label to the side panel (right side as viewed from the front of the instrument). Place the new serial number label below the labels that contain the regulatory marks.

NOTE. The MPI2-10-UP serial number label is included in the upgrade kit. The label lets Telestream service know that the instrument contains the upgrade kit.

- 15. Upgrade the instrument firmware. (See *Upgrade the instrument firmware*.)
- 16. Upgrade the software license. (See Upgrade the software license.)
- 17. Verify the upgrade. (See Verify the hardware upgrade.)

Upgrade the PRISM MPX2-10 Eye mezzanine board

Complete the following steps to remove the currently installed mezzanine board from the instrument and install the Eye mezzanine board:

- 1. Set the instrument so that the bottom is down on a static-free surface.
- 2. Remove the top cover as follows:
 - **a.** Use a TORX-driver with a T-10 TORX tip to remove the eighteen screws securing the cover to the instrument.
 - **b.** Lift the cover up to remove it from the instrument and set it aside.

3. Use the BNC nut driver to remove all five BNC nuts and lock washers.

4. Use a TORX-driver with a T-10 TORX tip to remove the four screws securing the rear panel plate to the instrument.

5. Pull the rear panel plate straight off the back panel.

NOTE. The GPIO board will keep the rear plate connected to the instrument.

- 6. Use a TORX-driver with a T-10 TORX tip to remove the two screws on either end of the back panel.
- 7. Pull the right side of the back panel away from the instrument.

8. Use the 11/32 inch socket nut driver to loosen the two lock nuts on the side of the Mixed Media board module.

- **9.** Slide the Mixed Media board and carrier frame away from the PCIe and power connector on the Slot Host board.
- **10.** Use a TORX-driver with a T-10 TORX tip to remove the four screws on the corners of the Mixed Media board.

11. Slide the Mixed Media board out from between the grinches as shown in Figure 16.

12. Turn the board over and disconnect the GPIO ribbon cable.



CAUTION. Make sure the back panel is pulled out enough to clear the BNC connectors on the Mixed Media module. Excessive pressure on the BNCs will cause damage to the connectors on the Mixed Media and mezzanine boards.

- **13.** Use a TORX-driver with a T-10 TORX tip to remove the screw from the mezzanine board shown below.
- 14. Remove the mezzanine board from the connector and set it aside.

- 15. Refer to Figure 19 and install the screw from the kit (part number 211-1117-XX) and the spacer post (part number 129-1889-XX) into the hole closest to second connector using the following method:
 - **a.** Insert the screw from the bottom of the board and use a finger to hold it in place.
 - **b.** Install the spacer post over the screen on the board, while keeping a finger on head of the screw; tighten the spacer post until tight.

- **16.** Locate the new Eye mezzanine board from the kit (part number 878-1285-XX).
- **17.** Line up the Eye mezzanine board with both of the connectors and press down until it is fully engaged as show in Figure 20.



CAUTION. Bending the Eye mezzanine board can damage the board or instrument. Avoid fully inserting the connectors until they are properly aligned; this prevents the bending of the board.

18. Use the TORX-driver with a T-10 TORX tip to secure the Eye mezzanine board to the main board using the two screws provided in the kit. Tighten these screws to $0.6 \text{ N} \cdot \text{m} (5.31 \text{ in-lb})$.

- **19.** Perform steps 8 to 12 in reverse order to reinstall the Mixed Media board back into instrument. Tighten the four Mixed Media board bracket screws to 0.6 N⋅m (5.31 in-lb).
- **20.** Secure the back panel to the instrument. Tighten two side screws to 0.9 $N \cdot m$ (7.97 in-lb).
- **21.** Tighten the two lock nuts on the opposite side of the Mixed Media board to 0.9 N·m (7.97 in-lb).
- **22.** Secure the rear panel plate. Tighten the four rear panel plate screws to 0.9 $N \cdot m$ (7.97 in-lb).
- **23.** Reinstall the rear panel hardware. Tighten the five BNC nuts to 0.9 N·m (7.97 in-lb).
- 24. Place the cover over the instrument and replace the top cover screws. Tighten the cover screws to $0.9 \text{ N} \cdot \text{m}$ (7.97 in-lb).

25. Apply the MPX2-10-UP serial number label below the existing MPX serial number label on the bottom of the instrument.

NOTE. The MPX2-10-UP serial number label is included in the upgrade kit. The label lets Telestream service know that the instrument contains the upgrade kit.

CAUTION. The MPX2-10-UP label is not inset and is at risk of damage. To avoid damaging the label, use caution when inserting or removing the instrument.

- 26. Upgrade the instrument firmware. (See *Upgrade the instrument firmware*.)
- 27. Upgrade the software license. (See Upgrade the software license.)
- 28. Verify the upgrade. (See *Verify the hardware upgrade*.)

Upgrade the instrument firmware

Before you begin Telestream releases updates to product firmware to add new features or to fix reported problems. Check the Telestream website regularly for new firmware releases.

You do not need to perform a firmware upgrade if your instrument has the latest version of firmware already installed. To determine if the firmware on your instrument must be upgraded:

- 1. Power on the instrument.
- 2. Verify the current software version installed on the instrument:
 - a. Touch the Settings icon to open the Settings menu.
 - b. Touch Utilities icon to open the Utilities submenu.
 - c. Touch Version to open the Version display.
 - **d.** In the Software section, make a note of the version number installed on the instrument.

Instrument Firmware version number

- 3. Verify the version of firmware at the Telestream website:
 - **a.** On a PC go to the Telestream website software page: <u>www.telestream.net/video/resources.htm#Software</u>
 - **b.** Click on the product and model title that best matches your instrument (such as PRISM) and in the list, find the software-upgrade package for your instrument.
 - c. Note the latest version number of the software-upgrade package(s).

Website Firmware version number

- 4. If the firmware version at the website is newer than the version on your instrument, you should upgrade the firmware.
- 5. Click the Firmware Release version for your instrument to download the update.
- 6. Go to the Firmware upgrade procedure.

NOTE. *The time required to complete the upgrade is about 15 minutes.*

If you want the details of what has changed in the release, download the Release Notes for the version.



CAUTION. Removing the power from the instrument during the upgrade process will corrupt the flash memory. If the flash memory is corrupted, the instrument will have to be sent to a Telestream factory service center to have the system firmware restored. DO NOT remove power from the instrument during the upgradeprocess.

NOTE. *If power to the instrument is lost before it begins erasing the internal flash memory, restart the firmware upgrade after the instrument reboots.*

Upgrade the Firmware

1. Copy the upgrade file with a .bin file extension from the upgrade package onto a USB memory device. You need approximately 1 GB of available space on the USB device.

NOTE. If the upgrade package included a readme.txt file, read the file before performing the upgrade. The file contains important information about the firmware release.

- **2.** Insert the USB memory device into a USB port on the PRISM monitor.
- 3. On the PRISM monitor, select the Settings icon () to open the Settings menu.
- 4. Select Utilities to open the Utilities submenu.
- 5. Select Firmware Upgrade. After the USB device has been scanned, the display lists all of the files on the USB device with a .bin file extension.
- 6. Select the file in the list, and then select **Install** to start the upgrade. (See **Error! Reference source not found.**.)

CAUTION. Removing the USB device or powering off the instrument before the upgrade is complete can cause upgrade failure. To prevent upgrade failure, wait until the **Installation Complete** message box is displayed before performing these actions. The upgrade may take up to five minutes.

- 1. Apply power to the instrument.
- 2. MPX only: Connect the external display.
- **3.** Connect the TG8000 SDI7 module output to the SDI 1 IN input on the PRISM monitor.
- 4. Set the SDI7 module to HD 1080 59.94i format using the following steps:
 - **a.** On the TG8000, push the front-panel **MODULE** button until the SDI7 module main menu appears.

- e. Select Save and close the menu.
- 7. Double-tap any tile to display it full screen.
- **8.** Press and hold anywhere on screen to display the application banner. Select Eye Pattern Display from the drop-down list.

- **9.** Press and hold anywhere on screen to display the application banner. Touch the Tool icon and select Align from the Jitter HP Filter drop-down list.
- **10.** Check for a stable eye diagram. Eye Amplitude and the actual wave shape depend on the generator signal. Eye Amplitude is typically 720 mV to 880 mV. Eye Risetime and Eye Falltime are typically 500 ps to 1500 ps.
